AND NOW, to wit, this day of day of , 2023, upon consideration of Plaintiffs' Motion for Class Certification, Brief in Support thereof, any Opposition, and evidence submitted by the parties, and after hearing, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

- 1. As set forth in the accompanying Opinion, Plaintiffs have satisfied the requirements of Pa. R. Civ. P. 1702, and the criteria of Pa. R. Civ. P. 1708 and 1709.
- 2. Thus, Plaintiffs' Motion for Class Certification is GRANTED for each of the claims asserted in Plaintiffs' Amended Complaint.
 - 3. This case shall proceed as Class Action, with the Class defined to include:

All owners or operators whose passenger cars, light trucks, motorcycles, and scooters were non-consensually towed from the Parking Lot by TAG Towing within the applicable statutes of limitation, and who, as a result, we charged and paid a fee in excess of the limits then set by 5 Pittsburgh code §§ 525.05.

- 4. Plaintiffs William J. Schneider, Casey Bruce, Diane Docchio, and Margaret Cusick are deemed proper Representatives of the Class.
- 5. Elizabeth Pollock-Avery of Lynch Carpenter, LLP, and Joshua Ward of J.P. Ward & Associates, LLC, are appointed as Class Counsel.
- 6. Within twenty (20) days of the date of this Order, Defendants shall provide Class Counsel with all information known about Class members, including (to the extent available) full names; last known addresses; last known phone numbers; email addresses; vehicle year, make and model; license plate numbers; and vehicle identification numbers.
- 7. Within forty (40) days of the date of this Order, Plaintiffs shall file a Motion to Approve Class Notice. Defendants may file any response within fifteen (15) days after service of the motion.
